

WEP/GPO NEWS

Join us on May 18th for a WEB/GPO discussion about the draconian impact upon teachers' retirement in 15 States and public employees in 26 States. California Congressman John Garamendi will speak about efforts in Congress to amend and/or repeal WEB/GPO and retired teacher Anne Hunt will explain how WEB/GPO hurts public employees' retirement and how UESF Retired Division members can support the fight to repeal it.

Important WEB/GPO info from Social Security Fairness:

• What are the Social Security Offsets?

The Government Pension Offset and the Windfall Elimination Provision Security cut retirement benefits that have otherwise been fairly earned by government workers.

• What is the Windfall Elimination Provision (WEP)?

The WEP is a penalty imposed on one's own Social Security retirement benefit when one begins to collect a pension from a public agency that did not collect FICA taxes during your employment.

What is the Government Pension Offset (GPO)?

The Government Pension Offset is a Social Security provision that penalizes individuals who apply for Social Security spousal or survivor benefits if they themselves worked for a state or local government in non-SS-covered employment and are entitled to a government pension from that employment.

What can be done to address the offsets?

We seek total repeal of both the GPO and WEP. In the 118th Congress (2023–24) the House of Representatives Social Security Fairness (full repeal) bill is: HR 82 introduced by Graves (R-LA) and Spanberger (D-VA).
