

NEW RETIREES LUNCHEON







SB. 765 TEACHERS: RETIRED TEACHERS: COMPENSATION LIMITATION

SB 765 was signed by Gov. Newsom on October 13, 2023. This bill is designed to lessen the devasting CA teacher shortage by temporarily modifying Teachers' Retirement Law ("TRL") so that qualified CalSTRS retirees can return to work in CA schools for the entire academic year in order to better meet the educational needs of CA students.

SB 765 hopes to accomplish this by (1) raising the CalSTRS maximum earnings limit from 50% to 70% of the median final compensation of all members who retired for service during the fiscal year ending in the previous calendar year and by (2) waiving the 180-day separation from service requirement under certain conditions. These temporary modifications of TRL take effect on July 1, 2024 to June 30, 2026, before reverting back to existing law.

Increasing the CalSTRS earnings cap, however briefly, will give some retired working teachers the breathing room necessary to earn a little more and possibly catch up with historic inflation.

OUTSIDE THE BOX

There is every indication that the big corporations that are now facing organizing drives, especially those generated internally by their employees, are going to use every legal trick in the book to avoid recognition (and in some cases illegal ones too) or, having been forced by an election to grant recognition, to avoid a mutually acceptable contract.

At the same time, we know there is a high turnover rate in some of these places, especially Amazon, and that turnover of the workforce is part of their "model." Organizing in a high turnover place is like organizing a hotel rather than a neighborhood.

Among other things that follow for me as an organizer is the idea of an alumni association. For one thing, the workplace community experience in their unionbuilding efforts is probably absent in their social media dominated worlds. Second, relationships formed at the workplace are often relationships that carry over into the rest of one's life. Third, it is likely that those who were part of an organizing drive would like to see a union formed even if they won't be contractual beneficiaries of successful results.

As a separate entity, an alumni association could do things a union can't do—like organize a boycott if the workers indicate that one would be helpful. Proper care should make it possible to avoid secondary boycott convictions in court, but there are probably plenty of lawyers who'd do pro bono defense work on a case like this.

An alumni association seems to me the immediate basis for broadening the base, especially if the alumni association could cut across lines to include several of these employers, but even if it only included one big one.

OUTSIDE THE BOX CONT.

Building it as a community and organization could create the possibility of longstanding commitment, especially if the organization engaged in these support activities:

- Nonviolent direct action
- Boycott action
- Corporate action (isolating the company in its economic milieu).
- Political support
- Solidarity work

And if it had these community-building "internal" dimensions:

- Mutual aid: everything from buying clubs to car pools to child care to, down the road, full-scale coops.

- Direct member benefits and services
- Social, cultural, athletic and educational activities.

An alumni association could charge meaningful dues so that it would soon be capable of supporting its own organizing staff. Credit card payments now make dues collection a much easier task. Any takers?

SCAMS: KNOW THE RED FLAGS

The most common types of scams will target you through fake emails, text messages, voice calls, letters or even someone who shows up at your front door unexpectedly. No matter which technique the scammer uses, you may be: •Contacted unexpectedly by phone, email, text, direct message or pop-up with a request for personal information or money. Never click a link or download an attachment from someone you don't know.

- Pressured to act immediately with an alarming phone call, email or text that plays with your emotions. Scammers may pose as an employee from a familiar organization and say there's a problem that needs immediate attention. Do not act unless you have verified the person who has contacted you and the story or request is legitimate.
- Asked to pay in an unusual way, like gift cards, bitcoin, prepaid debit cards or digital currency, including Zelle® to resolve fraud.
- Asked to provide personal or account information, such as an account verification code, bank account number or PIN. When in doubt, don't give it out.
- Offered a free product or 'get rich quick' opportunity that seems too good to be true? If something sounds too good to be true, it probably is. Never cash a check for someone you don't know.
