## THE FIGHT FOR WEB/GPO REPEAL AND SOCIAL SECURITY FAIRNESS CONTINUES

For the first time the House Ways and Means Committee is considering support of HR82 the Social Security Fairness Act and possibly voting to support repealing or amending the unfair reduction of hard earned retirement benefits of educators and other civil servants in 26 states, including California. There are now well over 300 co-sponsors of repeal legislation in the House, but it still needs to get out of the committee and onto the floor for debate and a vote.

On the home front it is more than disappointing that Speaker Emerita, Nancy Pelosi, has still failed to become a co-sponsor. Members are urged to call her office and request that she become a co-sponsor of HR82. Pelosi Washington, DC Phone: (202) 225-4965.

GPO and WEP essentially penalize us for choosing careers in public service. Write a letter to your representative now, urging them to repeal GPO and WEP.

HR82, the Social Security Fairness Act, is a bipartisan effort to redress a longstanding problem.

The best way for our union to push this bill across the finish line is by sending a flood of letters to our representatives today voicing our support.

<u>Every member of Congress needs to hear from public service retirees on this issue.</u>

Dolores Huerta, icon of labor and civil rights, celebrated her 94th birthday in April.

Huerta received an associate teaching degree from the University of the Pacific's Delta College in the early 1950s, but soon recognized that she could do more for more people through organizing.

Her career as an activist started when she was instrumental in founding the Stockton chapter of the Community Service Organization (CSO). Through this work in voter registration and social justice, she met Cesar Chávez and began the work of organizing farmworkers.

Her many awards and recognitions include the Presidential Medal of Freedom presented by President Obama in 2012.


#### **UESF ORAL HISTORY PROJECT READY TO ROLL!**

#### **NOTES & REMINDERS FROM CTA/NEA RETIRED**

- 1. SB 765 allows retired teachers to return to work before the normal 180 day waiting period goes into effect from July 1,2024 and expires June 30,2026
- 2. Disaster Relief Fund- Reminder that as as a CTA/NEA-Retired member if you suffer a loss to property from a natural disaster you may apply for compensation. If a request is made to CTA Member Benefits for assistance from the CTA Disaster Fund, an effort is made to verify the loss and justify the grant assistance. They may contact the CTA Staff or CTA/NEA Retired Leadership for verification of need.
