

May 13 Bargaining Report

Overview

After months of negotiations, the UESF special education bargaining workgroup reached an agreement on Special Education services with SFUSD on May 13. Special education has been a significant focus in the 2023 bargaining and the most recent reopener. We recognize the importance of advocating for improved working and learning conditions in Special Education in SFUSD. We have consistently addressed the district's lack of preparedness to engage in meaningful discussions and the need for essential data and information with resourcefulness and creativity.

The collective pressure from our members, our students' families, and the SPED community enabled the bargaining team to secure crucial outcomes during rising student needs. Some highlights include:

- Class ratio goals for secondary co-taught classes
- Workload model language in the CBA
- A initial workload model for the hybrid RSP/SDC role
- A caseload goal of 27 for RSPs, one below the state caseload
- Classified training timelines and a plan for professional development
- A clear path for resolving inequitable distribution of caseloads with ultimate decisionmaking in the Joint UESF - SFUSD special education committee
- Recognition of Early Ed Special Educators and a cap on sites for itinerant EED
- Agreed upon job audits for SDN & SSW including next steps after results

The extended timeline of this bargain has compelled the district to be more transparent and accountable in gathering and utilizing data to support students and families. Moving forward, your role becomes even more crucial. It will be up to site leaders and members at the sites to ensure that the district fulfills its contractual obligations. The Union Building Committee now has an even stronger contractual basis for shared decision making at the site AND the special education committee has been further empowered to support our members and students in special education.
