Not only was he our president and chair, but he also served on the San Francisco Labor Council and held numerous positions at the CTA/NEA and CFT/AFT levels. She was followed by a pair of speakers from **Blue Shield**, **Tiffany Gill and Charles Lee**.

The formal presentations and some questions were covered before lunch. The guest speakers were then invited to stay for lunch and meet the members individually to discuss individual concerns and other items that had not been touched on in the presentations.






BOOK GROUP

OHP CLASSES HAVE ENDED! NOW THE INTERVIEWS BEGIN!!!

Retirees who participated in the Oral History Project (OHP) were offered six online classes taught by two CCSF retired instructors. These classes were paid out of your union dues and offered to us through City College of San Francisco Extension. We learned a lot about many oral history projects, past and present, across the nation. You might have heard about Zora Neale Hurston and Studs Terkel in the past. But, did you know about the Wayne State's Walter Reuther Labor Archives holding many AFT interviews in their library? UESF will be adding our interviews to those when we finish.

We also learned about the Library of Congress and the Orange County Community College Retiree Chapter which solely started and became active due to the oral history interviews that took place of their recent retirees. And, right here in the Bay Area, we heard from domestic workers in the Mission District trying to survive during COVID, and at City College of S.F., AFT 2121 members were interviewed or were the interviewers of their earlier retirees. And the above is just to name a few of the outside speakers that we heard!

Now it's UESF's turn! All of the current UESF OHP classmates have all taken three of our very own UESF retirees who were instrumental during the strikes back in the 70s and who later formed your merged local (AFT and NEA) back in 1989. They have taken us through the modern era (all of our past presidents who are still with us will be interviewed). **But, we WANTED to interview about 60 people, not the 25 or so who were our top priority.**

So, it's not too late for you to join our Oral History Project so that we can tap into the other approx. 35 UESF members who were instrumental in developing the legacy of our union. If your time has become a little more free, please help us interview some of these folks. If the CCSF instructors are not around to teach you what they taught us, we UESF interviewers will get you up to snuff so that we can get to so many more people. If you are interested in helping us out, please contact Lisa Gutierrez Guzman and/or Ken Tray. Just leave a message in the union office. They will give it to us, and we will get you oriented. You will not have to drive or take public transportation to participate. All of the interviews will be on Zoom. HELP US get this important project done!



IN MEMORIAM

It is with profound sadness that we inform UESF-Retiree members of the passing of **Shannon O'Hara**. Shannon was fifty-nine years old and died peacefully in his sleep.

Assigned by CTA as a field representative for UESF, Shannon was one of the important behind-the-scenes figures who made the NEA/AFT merger work. In 2003, when the prior UESF office was sold, CTA was so far out of the loop that Shannon was not told. But, once involved in the work of the local, Shannon saw to it that CTA shared in all the appropriate activities and was a key figure in bargaining the contracts of the 21st century.

At the time of his death, Shannon had risen to the role of Regional Manager--one of the four positions directly under the CTA presidency. **There was no obituary nor services.**
